CONSENT TO DISCLOSE PERSONAL INFORMATION

TO: THE ONTARIO POWER AUTHORITY (the "**OPA**")

Capitalized terms not defined herein have the meanings ascribed to them in the FIT Rules, Version 2.1.

- Pursuant to Section 3.3(b) of the FIT Rules and Section 17.2(i) of the FIT Contract, in the case of a Community Participation Project, the OPA requires this signed Consent from 50 or 35 corresponding Co-op Members that are Property Owners, as the case may be, with respect to the Project that is the subject of the Application or Contract, as applicable, for the purposes of verification by the OPA of compliance with the FIT Rules and FIT Contract, ensuring the integrity and proper operation of the FIT Program, publicizing the FIT Program, and to allow the OPA to disclose to the Ministry of Energy, and certain other Ontario government ministries certain information about the Co-op Members for such purposes.
- 2. The OPA collects and uses (on behalf of itself, the Ministry of Energy and those other Ontario government ministries) and may possibly disclose to those aforementioned entities, certain information contained in the FIT Application and corresponding FIT Contract, as applicable.
- 3. The information on Co-op Members that may be collected, used and possibly disclosed (for the purposes set forth herein), includes without limitation, a Co-op Member's name, address, contact details (phone number, email address, for example) property ownership details, FIT Program eligibility characteristics and details supporting the Project's compliance with Community Participation Project requirements. Information that will be collected, used and or shared will be limited to that which the OPA reasonably believes to be necessary to ensure proper management of the Application and the FIT Contract (as applicable) and the integrity and proper operation of the FIT Program, including without limitation, FIT Program analysis, assessments, reporting, administrative, operational or planning purposes.
- 4. The OPA and Ontario government ministries may use information collected to contact the Co-op Member for verification purposes and other purposes associated with the Application, the FIT Contract and the FIT Rules (as applicable).
- 5. In addition, the OPA and Ontario government ministries may need to obtain certain information, such as property ownership information, and relevant Property Identification Numbers (or legal property descriptions) to establish compliance with Community Participation Project requirements and to otherwise ensure the integrity of the FIT Program, the Application and the FIT Contract (as applicable).
